

Instructions to Authors (Eurasian Journal of Forest Research)

Submission of manuscripts: Submit the electrical file of original manuscript (including figures and tables) from the author responsible for correspondence. Manuscripts submitted are subjected to review and editing by two reviews and a handling editor. A cover letter should be attached and contain a statement that the manuscript has been seen and approved by all authors. The electrical file of the manuscript may be made by either Microsoft Word, OpenOffice. The file name must contain the name of correspondence author. Table and Figures are also welcomed to write clear with use of Microsoft Excel and/or Microsoft PowerPoint, or OpenOffice but not insert them into the main text. Authors should keep copies of everything submitted. Submission of a manuscript is held to imply that the paper has not been published elsewhere and that, if accepted, it will not be republished in any other journal in the same or similar form without the Publisher's written consent. Articles are consisted of full paper, invited review and research materials (research materials mean technical report, rapid note, basic information of study site etc.). Upon receipt, the manuscript will be given a received date and sent to reviewers.

Arrangement : It is presupposed that manuscripts submitted are in their final form. All manuscripts should be written in English of an acceptably high standard. **Authors with a mother tongue other than English should have the language revised**. Manuscripts should be typed double-spaced with a right-hand margin (3cm), including reference list, legends for tables and figures. Mark the position of figures and tables in the right margin, and all pages in the upper right-hand corner with page number and author's name. New paragraphs should be marked with indentation, The SI system, which includes the metric system, should be used through-out. Footnotes and letter-spacing are not allowed in the main text. Each manuscript component should begin on a new page, in this sequence:

Title page with authors and their address (e-mail address, too),
Abstract and Key words,
Text (Introduction, Materials and Methods, Results, Discussion, or Results and Discussion)
Acknowledgements
References
Tables, Figure and legends for Figures

Title page: The title page should contain title of paper, running headline (max. 40 characters), author's last and first name (e.g. ABAIMV Anatoly P.; SHI Fuchen; MAMIYA Haruhiro), institution, department, postal address, post (zip) code and country. The main title should contain the words necessary for correct indexing with species names in Latin. Titles should be as brief as clarity permits.

Abstract and Key Words: The manuscript should open with an abstract not exceeding 300 words with five Key words in alphabetic order.

Author's Name: Full name should be described as order of LAST and first name; e.g., SHI Fuchen, ABAIMOV Anatoly P. and UEMURA Shigeru

"Introduction" should provide a general orientation of the subject and present the reasons for and aims of the study. It should be concisely written and not be a review of the subject area, but should finish with a clear statement of the question being addressed.

"Materials and Methods" (or Study sites and Methods) should provide sufficient details of the techniques used to allow them to be repeated. These must provide information enough to permit exact replication of the experimental work.

“Results” should not include material appropriate to the Discussion section. No discussion of the results is permitted in this section. Indicate in the left-hand margin the approximate position of Figures and Tables.

“Discussion” should not repeat results, but in a logical way interpret the main results with reference to relevant figures, tables and references. It should not be over-speculative, reiterate the results.

Citation of the references in the manuscripts: The reference should be cited chronologically in the manuscripts as; Araya and Shimizu (1971), Hutchinson *et al.* (1986) (if more than two authors) or (Shibuya and Matsuda 1971, Hutchinson *et al.* 1986) in the sentence.

Tables and Figures: All tables and Figures should be submitted as independent files or the form that can be inserted by copy and paste. **Don’t insert them to the main text.**

Photographs: Photographs are recommended to be saved as JPEG format.

Legends: Enter the Legends of Tables, Figures and Photographs at the end of the files.

Author proofreading: After editing, the editor would use E-mail between author for proofreading work.

More detailed items will be decided by editorial committee of the EJFR of Hokkaido University Forests, FSC.
